Are there other deductibles for specific services?	No.	You don't have to meet <u>deductibles</u> for specific services.

Do you need a <u>referral</u> to see a <u>specialist</u> ?	Yes. An electronic <u>referral</u> is required to see a <u>Network Specialist</u> . Does this plan provide Minimum Essential Coverage? Yes
